Cllr Pratt offered to pay towards electric car charging points at the village hall. It won't be possible to plant fruit trees behind the village hall due to health and safety.

Permission has been granted to the following applications:

DC/19/05393 – change of use and development of site to provide 5 no single storey dwellings and upgrade existing access at Land on the South side of Needham Road, Barking

DC/19/05483 - Kittlesfield, The Tye, Barking - Erection of a rear extension and change window and to doors. (following demolition of conservatory)

Permission was refused for the following application:

DC/19/01056 – Application under section 73 of the Town & Country Planning Act for the variation of Condition 2 relating to (1215/17) (Approved Plans and Documents) and the removal of Condition 3 (Materials) at Ashburnham Farm, Needham Road

Bpc12/20 Easement for land north of the Tye

It was agreed to appoint Savills as land agent to act for the Parish Council. Bates, Wells and Braithwaite have been appointed as solicitors.

It was agreed to form a committee to oversee the construction of a footway along the Tye. Cllrs Lillie, Bailey Tabberer and Horsham to form the committee. Clerk to meet Cllr Bailey to organise a letter to residents, easement holders and those with grazing rights. Letters to be posted when ready.
