BPC137/13 PUBLIC FORUM

BPC138/13 TO RECEIVE APOLOGIES

BPC139/13 POLICE REPORT (see attached report)

BPC140/13 DISTRICT COUNCILLOR STEPHEN WRIGHT (see attached report)

Cllr Wright's report included proposed tomato greenhouses at Great Blakenham, postponement of Bramford/Twinstead Pylons, Anglia One Windfarm route, housing development at Great Blakenham, solar farm development at Baylham, and the reorganisation of Babergh & Mid Suffolk District Councils.

BPC141/13 – COUNTY COUNCILLOR JULIA TRUELOVE'S REPORT (see attached report)

Cllr Truelove also reported that she had been contacted by Mr & Mrs Donaldson regarding the hedge at Tye Green but emphasised the fact that she is not in a position to intervene.

v) Replacement Street Light – It was reported that the Clerk is unable to source the street light any cheaper, so the order has been placed with Suffolk County Council.

- vii) Land Adjacent to 27 Fox Meadow Cllr Hollocks reported that the plot of land owned by MSDC is being let to the new occupants of 27 Fox Meadow for garden use.

BPC147//13 PLANNING

- i) 2865/13 The Piggery, Moat Farm Barns, Barking It was reported that although the Clerk had requested an extension, this had not been approved and the decision to grant planning permission has already been given by MSDC.

BPC150/13 DRAINAGE PIPE REQUEST

It was reported that Suffolk County Council is seeking permission to lay a pipe across the Tye from the road (B1078) to the ditch adjacent to Rivendell, in a bid to drain surface water away from the road. This stretch of road repeatedly floods after significant rain fall, and previous attempts to remove surface water by other means have failed. **Decision** – It was agreed to grant permission for SCC to run a pipe across the Tye provided it is placed next to the access track and that the Tye is made good afterwards. Clerk to respond accordingly.

BPC151/13 FOOTWAY

It was reported that SCC Highways has now responded to the Council's request to continue with the project to provide a footway through the Village. The letter from Philip Wright indicates that there are no funds to continue with the project and quoted John Goodyear's original caveat (October 2006) that the continuation of the project was "subject to continued funding of rural pavements in future LTP's and assuming the current budgets are maintained", which has not happened, so the funding for rural paths no longer exists. SCC is no longer in a position where it can afford to lay 1000m of footway due to the economic climate which currently exists, even if the project is spread over many years as was originally intended.

Decision – It was proposed and resolved to ask SCC how much such a phased footway would cost. Clerk to action.

BPC152/13 CLEANING OF WAR MEMORIAL

It was agreed that the War Memorial on the Tye does need cleaning. Cllr Truelove was invited to speak, and reported that she had just learnt that the Community Covenant will now receive smaller grant applications, and if the Council were to apply for one to have the War Memorial cleaned, she would support the application. **Decision -** It was proposed and resolved to ask the Clerk to seek an alternative quote from a local firm and also the War Memorials Trust, and to liaise with Cllr Truelove regarding the grant.
